## **InterCement Continues Discussions with Key Creditors**

**São Paulo, May 30th, 2023** – InterCement Participações S.A. (the “Company”) clarifies that, as announced in its material fact, dated May 10, 2023, the Company engaged advisors to support its assessment of alternatives for its capital structure. In this connection, the Company’s advisors have commenced discussions with the Company’s key creditors to formally request waivers on its 2Q23 payments, including a R\$100 million loan from Banco HSBC S.A. that came due on May 25, 2023, while a more comprehensive restructuring proposal is developed.

The Company expects to continue constructive conversations with its creditors, aiming to address each of them in the short-term, and greatly appreciates their continued support given the Company’s operational excellence during this period of challenging macroeconomic conditions in Brazil and Argentina, its principal markets.
